I expressly waive any such claim for compensation or liability on the part of Nonprofit(s) beyond what may be offered freely by Nonprofit(s) in the event of injury or medical expenses incurred by me.
3.	<u>Medical Treatment</u> : I hereby Release and forever discharge Nonprofit(s) from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with Nonprofit(s).
4.	Assumption of Risk: I understand that the services I provide to Nonprofit(s) may include activities that may be hazardous to me including, but not limited to cutting, splitting and stacking firewood, involving inherently dangerous activities. As a volunteer, I hereby expressly assume risk of injury or harm from these activities and Release Nonprofit(s) from all liability.
